† Admission to Upper-Division Standing does not waive individual course prerequisites (e.g., course prerequisites for BA 377 are: BA 273 and MATH 272).

**NOTE:** A total of 120 credits are required for the BBA degree. Of those 120 credits, a student must successfully complete at least 60 credits outside the fields of ACCT, BA, CIS and ECON. Six credits from Applied Statistics (AS), BA A273 or BA A375 and nine ECON credits may be counted as being outside the business area. At least 50% of the credits required for the BBA degree must be earned at the University of Alaska Anchorage. A minimum of 45 upper-division credits is required. **A grade of "C" or better is required for all ACCT, BA, CIS, & ECON courses.**
